# Q: WHAT IS THE CAPACITY BUILDING MENTORSHIP PROGRAM?

A: The Washington State Department of Transportation (WSDOT) created the Capacity Building Mentorship Program, previously called the Mentor Protégé Program, in response to the Governor's <u>Results Washington</u> Goals diverse business participation goals, as follows:

- Minority Business Enterprise 10%
- Small Businesses 5%
- Veteran Owned Businesses 5%
- Women's Business Enterprise 6%

This program is part of WSDOT's <u>State Funded Diversity</u> <u>Roadmap</u>.

#### Q: WHAT IS THE STATUS OF THE CAPACITY BUILDING MENTORSHIP PROGRAM?

A: WSDOT's Capacity Building Mentorship Program is transitioning from its partnership with <u>THOR Construction</u> to the Tacoma <u>Minority Business Development Agency</u>. Additionally, <u>Sound Transit</u> is partnering with WSDOT to expand the pool of applicants. Another round of applicants will be accepted this spring.

## Q: IF I AM CURRENTLY IN THE PROGRAM AND SATISFIED WITH MY MENTOR/PROTÉGÉ, WHAT DOES THIS MEAN FOR ME?

**A:** You may continue with your partnership and monthly reporting.

#### **Q: HOW DO I FIND A MENTOR?**

**A:** WSDOT, Sound Transit and the Minority Business Development Agency are currently planning the next round of pairing. More information will be made available shortly.

#### Q: CAN A PROTÉGÉ FIRM BE A MENTOR?

**A:** Yes, a Protégé can also serve as a Mentor. Larger Mentors are able to have more than one Protégé. Due to current demand, Protégés are only able to have one Mentor.

# Q: ONCE MY FIRM IS IN AN ESTABLISHED MENTOR PROTÉGÉ RELATIONSHIP, ARE THERE OTHER REQUIREMENTS THAT MY FIRM MUST FULFILL?

**A:** Per the program requirements, participating firms must report monthly on the progress made under their Memorandum of Understanding.

# Q: HOW LONG DOES IT TYPICALLY TAKE TO GET AN APPLICATION APPROVED?

**A:** Mentor and Protégé firms must complete the application process. Additionally, Protégé firms must be interviewed and their organization assessed for areas the Mentor and Protégé should focus on.
