Message from the President

**Tabor Neighbors:** 

I hope you are all faring as well as possible given the COVID-19 situation.

This period has been difficult for all of us and we here at Tabor 100 have done everything we can to make it better for our members and others in the community. We have attempted to share with you opportunities both to enhance your business and secure funding to weather this pandemic. We continue to provide assistance and encourage you to reach out to us at patients. Latinos are also suffering covid19@tabor100.org if you need anything that you believe Tabor 100 can assist with.

We are anxious to hear from you about opportunities you may be aware of and want to share with our members. We appreciate the many members who have shared with us the various offerings of government agencies and private companies designed to help our businesses "weather the storm" of this pandemic. We have dutifully passed the information on and know that some of you have been blessed by this generosity.

I want to take a minute to encourage all of you to heed the directives to wear masks, practice social distancing, and adhere to the mandates of health experts as we work our way through the COVID-19 pandemic.

You have read the reports, including an article in this newsletter last month, about the disproportionate toll African Americans and Latinos are experiencing from COVID-19.

Information about who is getting the disease and who has died from it is incomplete due to poor tracking and

sometimes an unwillingness to release the data. Regardless, it is confirmed that while African Americans make up 13% of the nation's population, we account for 30% of the COVID-19 disproportionately, even here in Washington state where they represent 13% of the population, and 25% of those infected.

I urge you to take the necessary precautions and protect yourselves. If you are Black or Latino, you already fall into a high risk category. If you suffer from diabetes, high blood pressure, obesity, chronic lung disease, moderate to severe asthma, liver and kidney disease, or are over 60, you have another strike against you.

My role at the Tabor HUB will be to help our members stay focused and persevere during these challenging times."

We are currently accepting applications on our website (https:// www.seattlecu.com/sba-loans) and highly encourage you to utilize Tabor 100's technical assistance in order to make sure your application and paperwork is as complete as possible so it can be submitted quickly. We do not know how long the funds will last so please act quickly.

Regular Business and SBA Loans and **Business Services** – SCU offers traditional business loans and services that may complement emergency loan programs. Please inquire on our website for more information (https:// www.seattlecu.com/business).

We recognize that these times are very challenging and dealing with the unknown is stressful and disorientating. We are willing to work with you and provide guidance on how you can access financial resources for your business. #### TABOR MEMBERS FIND SUCCESS IN COVID-19 PAYROLL PROTECTION PROGRAM

Tabor 100 has worked to make sure members and others of minority business community know about the federal Payroll Protection Program (PPP).

The Seattle Credit Union CEO has penned a letter elsewhere in this newsletter expressing his institution's commitment to Tabor 100. The Credit Union is assisting the minority business community in this pandemic using the PPP process and other mechanisms that get direct funds to our businesses.

The PPP provides loans to sole proprietors and businesses with employees and carries a 1% interest rate that a business does not need to start paying back for six months. In addition, if the loan is used for eligible expenses (including payroll, mortgage interest, and utilities), it can be forgiven.

If you receive Payroll Protection funds, follow the rules regarding what they can be spent on so that after eight weeks, you can apply for "forgiveness" with your lender and have the loan fully or partially terminated.

Tabor 100 encourages minority businesses to reach out to the Seattle Credit Union which is taking PPP applications.

George Frost, owner of GW Frost and Associates recently wrote to say:

"I am a sole proprietor. I finally decided to apply for the SBA PPP loan through the Seattle Credit Union after hearing from Tabor 100 that the credit union still had PPP funds. After just four days from the time I completed the application I received notice from

the Seattle Credit Union that SBA had approved my PPP loan application.

Thanks for keeping Tabor 100 members informed of available resources."

Charis May Hnin, Principal and Chief Strategist of Talitha Consults said the following:

"A few weeks ago, I contacted numerous banks including the institution I use for my business to apply for Paycheck Protection Plan (PPP) loan.
Unfortunately, none of the institutions could accept my application due to a high volume of applicants. from the first round. I was distraught!

Then I saw an email from Tabor 100 President, Ollie Garrett. In her email, she encouraged Tabor members to apply for PPP through the Seattle Credit Union. Also, to let her know when Tabor members have applied for a loan so she can advocate for the application process. At first, I was skeptical but then I thought, Why not! Here is an opportunity to act and someone will advocate for me! So, I changed my attitude and did exactly as her email outlined.

The steps I took were: 1) I opened a business account with the Seattle CU, 2) I mentioned to the CU rep that I am member of Tabor 100 and that the President of organization is advocating for me. Guess what?? On the same day my business account became active, I got an email from a loan

processor from the CU for PPP. The rep walked me through the process and assisted me with the application.

I am so very pleased to inform you that the representative at Seattle Credit Union was very helpful and expedient in helping my business apply for the loan. I am thankful for

Tabor 100 and Ollie for taking care of the Tabor family by sharing

useful resources and direction for actionable steps that I can take so small, minority and woman-owned business like mine can remain resilient during these trying times."

# Mayor Jenny Durkan Announces Initial 250 Grantees of the Small Business Stabilization Fund

Mayor Jenny A. Durkan announced the initial 250 grantees of the City's \$2.5 million Small Business Stabilization Fund. The fund provides \$10,000 grants to small businesses financially impacted by COVID-19. Nearly 9,000 small businesses applied for the first round of the City's Small Business Stabilization Fund, demonstrating that the need goes far beyond what the City can provide without further support from the private sector, philanthropic partners and economic relief from the federal government.

The \$2.5 million expanded Small Business Stabilization Fund is funded by federal Community Development Block Grants (CDBG). The federal government requires eligible CDBG small business awardees to have five employees or less and for the business owner to be at or below 80 percent of the Area Median Income. In addition, the Mayor directed OED to focus outreach on historically underserved small businesses, and nearly 80 percent of the 250 grantees identify as small business owners of color. After screening for eligibility, businesses were categorized as being from high or low-displacement areas of the City, and then awardees from each displacement category were selected by lottery. Weighting the investments towards high-displacement risk areas allowed the City to target businesses that are more likely to experience economic shocks. OED received around 80 applications when the department launched the first Stabilization Fund back in January 2020.

Mayor Durkan and the City of Seattle have worked to implement a series of actions that support artists, nonprofits, small businesses, and workers, including:

- Deferring utility payments for customers impacted by COVID-19
- Implementing a temporary moratorium on residential, small business, and nonprofit evictions to provide relief for working people financially impacted by COVID-19
- Creating temporary restaurant loading zones to facilitate curbside pickup at restaurants
- Announcing a small business relief package that included deferred business taxes and a stabilization fund
- Creating a new Arts Recovery Package to provide immediate financial relief to artists and cultural organizations that have been impacted by COVID-19
- Providing 6,250 Seattle families with \$800 in grocery vouchers
- Providing rent relief to tenants of City-owned facilities; and
- Partnering with United Way of King County and King County to invest \$5 million in rental assistance to help families stay in their homes.

#### **WMBE Program**

The City actively supports utilization of WMBE on City contracts as both primes and subcontractors, and each City department establishes plans and annual voluntary goals for WMBE inclusion in consulting and purchasing contracts. The City recognizes WMBE firms that self-identify with at least 51 percent minority or women ownership. To learn more contact Miguel Beltran at 206-684-4525.

#### **Priority Hire**

City construction projects of \$5 million or more operate under a community workforce agreement (CWA) and are required to have a percentage of project hours performed by workers living in economically distressed areas and to achieve goals for hiring women and people of color. #### **Acceptable Work Sites**

The City requires that our construction work sites are respectful, appropriate and free from bullying, hazing and other similar behaviors. PC monitors work sites, provides trainings and materials, responds to complaints and conducts enforcement as needed. For more information, contact Michael DeGive at 206-386-4128.

#### **WMBE Technical Assistance**
