Tanuary 15th, 2020, Tabor 100 had its grand opening. The following month on the same date we learned of our first case of COVID-19. Thirty days after that, our Governor ordered a statewide shutdown.

With business at a standstill, we asked what we could do to support our members? How can we prepare them to win new contracts after COVID?

During one meeting, we asked 100 members to stand up if they were not DBE certified or certified with the state. Over one-half of the room stood up. We had work to do!

We connected with OMWBE and started work to get all remaining members certified. We supported noncertified members who needed help with OMWBE certifications.

The State of Washington contacted Tabor to publicize emergency loans for small businesses. The City of Seattle was offering a \$10,000 grant. We worked with the city to help our members qualify. This activity led us to federal grant opportunities.

The death of George Floyd brought our members together. We created the Black Business Equity Fund. Our goal was to raise over one million dollars to support Black-owned businesses. We wanted to revisit this tragedy in five years and say this was how we responded in a time of need.

Covid was and still is difficult for everyone. We received calls from people saying they can't sit another day at the kitchen table. Was the Bruce Harrell room or Larry Gossett room available?

We were equipped and ready. We had hand sanitizer by the gallon. Gloves, masks, thermometers. Not one-person experienced covid from our cherished interactions. We were a safe and social place. Together we made it.

We had all of the PPP equipment, vaccination clinics, hand sanitizer, gloves, masks, and for two years Tabor was safe. Not one COVID case here.

On behalf of all of the Tabor 100 Family, we are grateful to those who supported us and a nod to our founding sponsors. We couldn't have accomplished this without you.

Love Always Wins The Hollingsworth Hemp Story

oy Hollingsworth and her brother started growing cannabis in a closet. That closet grew into a farm. The farm, in turn, launched a family legacy.

Joy established Hollingsworth Cannabis Company in 2013 when recreational marijuana was legalized in Washington state.

Joy's brother and father know all too well the sweat, tears, and bone-crushing labor required to develop and operate a farm. The pair planted the symbolic seed for Hollingsworth Hemp and created the company vision.

As the farm started producing cannabis, Joy's uncle Melvin suffered a serious injury. Aunt Jackie's began experimenting with hemp-based treatments to replace harsh prescription drugs with soothing and effec-

tive natural remedies. Aunt Jackie's salve was born from the effort.

Hollingsworth Hemp products are available in all 16 PCC grocery stores in Washington including PCC's new store in Downtown Seattle.

Hemp seed oil comes from hemp, a cannabis plant similar to marijuana. It contains almost no THC, the com-

pound that creates the euphoric high of marijuana. Hemp contains CBD rather than THC. CDB is prevalent in treating anxiety and epilepsy.

Joy says the oil is a natural moistur-

> izer- making it ideal for nourishing salves, soaps, and lotions. Joy also feels good about cultivating hemp

for oil because it is more sustainable than avocado or olive oil.

From humble beginnings on a farm, the Hollingsworth Hemp Company was born. We love the result- a flagship lotion infused with CBD, and Aunt Jackie's wonderful salve. High-quality hemp products we truly love.

Joy obtained funding through a BBEF grant and developed her PCC grocery store line. The catalog quickly expanded to many other hemp-based offerings - candles, bath bombs, soap, conditioner, daily moisturizer, and hand sanitizer, all made from hemp seed oil along with other natural plant-based products. Find your Hollingsworth Farms t-shirt and hoodie there too.

My family has a lot of wisdom and love. This place will be rocking and rolling with four or five black women, says Joy. I get a lot of energy from them. I know sometimes it feels funny to say, oh, this product's made with love, but it is.

If there is a thread for Joy that connects her family and the growth of the two businesses, it's perseverance and resilience.

Tabor's Black Business Equity Fund has helped Joy's business thrive.

She appreciates Tabor's support of local black business ownership. Owners can network, learn, connect, and share opportunities with Tabor's help.

Black and brown communities have been underfunded, and resources have been deprived so significantly that five, ten, fifteen thousand dollars can mean the world to someone, she says. Joy's passion doesn't end with hemp. She plans to give back to the black community through scholarships and access to sports opportunities. Joy is a role model for black girl empowerment. A true mentor who will lead and inspire young black girls to business ownership.

I think representation matters, she says. When you see someone who looks like you, it gives you strength and hope and inspires you. Whether it's a female, someone's black skin, or someone who comes from the same neighborhood.

I'm hoping that just by being in a space that other black women aren't in, I can inspire someone, in the same way, I was inspired.

Black Business Equity Fund Donor Spotlight

Q: Tell us a little about what you do.

A: In essence, I build good, impactful relationships for Vulcan Real Estate. This means building trust and partnerships with community stakeholders, leaders and organizations, particularly in neighborhoods where Vulcan has assets or projects. It is our goal to be seen as a trusted community partner.

Q: What's Vulcan's relationship with the Black community like?

A: Our project at 23rd & Jackson is a testament to our positive relationship with the Black community. While the project was complete before I joined Vulcan, I know of the continuous efforts and focus to bring that project to fruition. It wasn't easy, yet Vulcan has a deep commitment to the communities and neighborhoods where we develop and listening to community input helped shape the project. Today, we have a space with diverse residential tenants, Black-owned businesses, and visual art created by over a dozen Black artists, all with connections to the Central District.

Our head of real estate, Ada Healey, was clear that creating opportunities for small Black-owned businesses in the retail spaces in the project was a priority for her and for Vulcan. I have a personal connection to the CD (as I call it); it's where I was raised, and I know for some people real estate development can be perceived negatively, so it's especially important not to shy away from the good that can come from it. At 23rd & Jackson, you'll find Boosh, QueenCare, and Simply Soulful (coming soon), all retail businesses owned by Black entrepreneurs. It's my sincere hope that these businesses will receive the needed support and resources to sustain them for many years to come. It is our commitment to best honor historical spaces by listening to community, doing our part, and maintaining good partnerships with organizations like Tabor 100.

Q: How did you come to be involved in the BBEF?

A: Supporting the BBEF and Tabor 100 is part of a longer, broader story for Vulcan. We've always been thoughtful about our role in the community, and we've partnered with Tabor 100 for many years, through support of their Minority Business Expo,

Annual Gala, Tukwila HUB, and other avenues. When I joined Vulcan, we were already committed to funding the BBEF, and our partnership has been one way for us to offer some hope during the pandemic and hopefully beyond. It just simply made sense to invest as we all witnessed the negative impacts of the pandemic on small businesses, and it made even more sense to support Black-owned businesses by investing in Tabor and the BBEF. I was honored to serve on the inaugural BBEF application review committee and help select the first round of BBEF grantees.

Q: What does Vulcan hope to accomplish through its gift to BBEF?

A: Vulcan has a unique role to play in the BBEF. We're not only a funder, but a developer in Seattle's historically Black community, and we have the opportunity to encourage and support business owners that lease retail spaces from us. This means we can be creative and thoughtful about all the different ways we can support the community: as a property owner, as a funder of BBEF, and as an advocate. Our hope is two-fold: that Black-owned businesses in the region will grow, thrive, and sustain for many years to come, and that Tabor 100 will be able to support businesses with much need resources. Ultimately, the pandemic

Ultimately, the pandemic exposed the economic disparities that have long impacted Black-owned businesses, but it's also exposed an opportunity for organizations to offer more than just words – offering both hope and funding. Vulcan has stepped up along with PSE, Symetra, Amazon, the Kraken, and others as early funders. People can say "Black Lives Matter," but one thing we need to say as well is "Black businesses matter."

Black Business Equity Fund: Partnering with Tabor 100 on the BBEF

By partnering with Tabor's Black Business Equity Fund, companies can take a bold step toward racial and economic equity in our region

In 2020, Tabor 100 launched the Black Business Equity Fund (BBEF), intending to raise at least \$4.5 million over the next three years. We raised \$1.5 million last year and awarded nearly \$500,000 to Black-owned firms in Puget Sound in 2021. Initial funding came from the Seattle Foundation, Vulcan Inc., Puget Sound Energy, Amazon, Facebook, and many other companies and individuals.

Well-documented barriers explain the high rate of closures of Black-owned businesses, including a lack of access to bank credit, low cash reserves, and a scarce network of trusted advisors to guide them through difficult times. The Black Business Equity Fund addresses these barriers with access to capital, technical assistance, and business opportunities.


